GENERAL TERMS AND CONDITIONS

1. Bookings and payments

The customer can make a booking as follows:

- Via other communication channels (WhatsApp, Messenger, Viber and the like)
- On website
- Using booking channels (Booking, Arbnb oth.)

All prices are in euros. VAT is not charged under paragraph 1 of Article 94 of ZDDV-1 (we are not liable for VAT).

Booking is confirmed after 50% of booking is paid. We send confirmation email when we receive payment. If payment is not provided in 24 hours – booking is being canceled. Contact us via email if you have any problems. Rest 50% (second half) needs to be paid before arrival.

2. CANCELLATION AND BOOKING CHANGES

Following conditions apply to cases of cancellation:

- 10 days before arrival without cancellation fee
- 5 days before arrival 50% of the total price.

In case of early departure, the amount will be charged for the entire stay. In case of non-arrival, it is charged according to the conditions of cancellation - 50% of the total price. The non-arrival is considered that the guest did not arrive by midnight on the day of arrival and we were not notified of the later arrival. In this case we can immediately release the reservation and do not guarantee the availability of the apartment.

Our main service is Holiday rentals of apartments for:

- max 2 persons (Celje Center Apartment),
- max 5 persons (Koper Center Apartment),
- max 7 persons (Golte SkiCenter Apartment),

Booking price includes nights in full equipped apartment with bedding for number of guest, internet and TV use.

Towels can be prepared on request. Use of towels is being charged 30EUR per stay.

3. ONLINE CHECK IN

According to law of Republic Slovenia all guests needs to be registered in time of stay and turist tax needs to be charged. Check in is provided only ONLINE before arrival. For all guests we need following data:

- Name and surname
- Gender
- Nationality
- Number of document (ID or passport)

Guest can provide the data by texting via email or phone or pictures of the documents can be provided where data can be clearly seen.

4. ACCESS TO THE APARTMENT

After providing information requested for online check (stated in point 3 of this document) and payments being provided (stated in point 1 of this document), Guest receives a PIN code for entering the Apartment. In case Guest does not provide stated above, entering the apartment is not possible.

6. **DISPUTE RESOLUTION**

The parties agree that in the event of a dispute, they will try to resolve it amicably, otherwise the Slovenian courts will have exclusive jurisdiction to resolve disputes. Slovenian law applies to all general conditions.

Pets are not allowed.
